



A. General Terms and Information

1. The company under the corporate name "WALLBID INSURANCE & REINSURANCE BROKERS Single-Member Société Anonyme" (hereinafter referred to as "Wallbid") is dully registered in the Special Register of the Athens Chamber of Tradesmen as an insurance and reinsurance broker under registration number EEA/501 and is subject to the supervision of the Bank of Greece, specifically the Department of Supervision of Professional and Private Insurance. The use of Wallbid website, www.wallbidbrokers.gr, is governed by the present terms and conditions, which all users - meaning natural or legal persons who access or make use of the website (hereinafter referred to as the "Users") - are requested to read carefully and comply with. By visiting the website, Users shall be deemed to have read, understood, and unconditionally accepted these terms.
